Suscription Rates: Subscription rates are \$10.00 per year for members and nonmembers.

Membership Policy: Any individual with interests, beliefs and actions consistent with the purposes of The Maverick Grotto and The National Speleological Society is eligible for membership. Acceptance of new members is based on payment of dues and a mandatory three trip requirement with at least three different grotto

members. These three members shall act as sponsors. At least one sponsor must attend the meeting at which the membership vote is taken. A two-thirds majority vote of the members present will be required for acceptance.

Colorado Bend State Park

TSA Project for 1993-1994

Project dates:

October 8-10,1993

December 10-12, 1993

February 11-13, 1994

April 8-10, 1994

The Colorado Bend State Park project is only scheduled for four weekends during the 1993-1994 caving season. The project weekends are listed above. If you attend the park on weekends other than the dates listed, do not go to the TSA campground. Please proceed to the river office and pay the normal park entry fee. There is no caving during non-project weekends.

During project weekends, normal arrival will be Friday night with camping at the TSA campground. Friday night is also a time to register. Ed Young will have release forms and other materials to be handed out for the weekend. Everyone must sign a release form every weekend they come out. Saturday arrivals are discouraged and cavers who plan to arrive Saturday must pre-register with Ed Young at (214) 262-8188 prior to Friday of the project weekend. The project day usually starts around 10:00 A.M. Saturday morning and lasts until around 6:00 P.M. Written reports for each team's activities for the weekend should be turned in by Sunday morning. There may be Corman Cave trips available Saturday

night to project participants. Sunday is usually an open activities day for the TSA volunteers. A limited number of people may visit certain caves, so check with one of the project coordinators Saturday and make your arrangements in advance.

Project goals for this year include the following tasks. We hope to finish ridge walking the area East of the TSA campground to the river front. This activity includes tagging caves, marking their location on a topographic map and exploring the caves. We will be writing descriptions of these caves as they are explored. We will begin writing cave descriptions of previously documented caves, and checking existing descriptions for accuracy. Very few caves have been surveyed and this will be one of the major activities of the project. Overland survey will continue in the areas where cave density is high enough to warrant this method of locating the caves on topographic maps.

Other activities will come up during the project and these they will be scheduled as time permits. We will have more details available during our first project scheduled for the second weekend in October. Have a safe caving trip and hope to see you this fall. MULTI-GROTTO RIVER STYX SURVEY PROJECT by: Donna Anderson

Although many of us have talked about re-surveying River Styx for several years, it was not until Pete Lindsley suggested putting in some permanent bench marks that we really got serious about the project. A new map is needed to include the many passages which have been located and some that have been dug out. Also, many of the passages have undergone changes because of the fact that it is a gypsum cave. We took a quick one day trip out to Styx, set some bench marks and discussed creating a joint grotto project. Pete asked me if I would be willing to be the Project Director. After a bit of discussion, I agreed to do this. We decided it will be a joint

grotto project for any grotto who wishes to participate. It will also be a learning project for any individual who wants to try to do a cave map. I will be coordinating the areas surveyed and collecting the survey data from each group. I will then mail copies of all survey notes to anyone who wants to try their hand at making a map. If you have never wanted the responsibility of making a map because you were unsure how it would turn out, or if it would turn out, now is your opportunity. You will be able to compare your map with others. Whether you are just interested in trying out your new computer map program or if you want to do the actual drawing, you

are welcome to join us. When the project ends and everyone who desires to make a map has done so, a committee will be formed to look at all the maps and check any slight differences. A final report, the map and some of the photos will be given to the ranch family. It will also be a learning project for anyone who wants to learn how to survey. There is a river entrance and also a dry entrance. There is plenty of dry walking passage to survey; there are also lots of crawlways on side passages. For those with wet suits, the water passage, which is very beautiful, will also be surveyed. If you are a photographer, there is a need to set up some permanent photo stations. For those who would like to work in a conservation effort, there is graffiti which needs to be removed. We also need a few more bench marks set. If you want to work on a dig, there are several opportunities if you are small in stature and enjoy crawiways. So far, four grottos have made a commitment to this project. All other interested grottos or individuals are welcome to join us. Project dates are the last weekend of September, October, and November: September 25 & 26; October 30 & 31;

November 27 & 28. (However, if it rains, the trip will be canceled as the cave floods.)

River Styx is the largest gypsum cave in Texas with over 8,000 feet of passage. It ranks high on the list of longest caves gypsum or limestone in Texas. It is located in King County between Benjamin and Guthrie. Air flow through the cave makes this one of the coldest caves in Texas. Water temperature in the cave ranges from 32 degrees during the winter months up to 55 degrees in the summer which makes this the coldest cave water in Texas. The water passage is well over 1,000 feet long. There are 3 species of bats in the cave the Mexican brown bat being the most common.

We will camp at the end of the road overlooking the Wichita River. We will camp there Friday and Saturday nights. We will survey on Saturday. On Sunday, anyone who desires to see more of the cave may do so. Salt Spring Cave is also a short walk from the campsite and is definitely worth a visit. 
location. A swimming hole nearby is available for the after-dig cleanup. Call Bob Cowell [{210}662-9171 for more information.


